  - Other health professions literature to support


### Methods & Results


- Qualitative Survey IRB approved for distribution (STUDY00014150)

- 188 complete responses





# **Discussion / Conclusion**

- Nursing
- ER BB and Core voted 1<sup>st</sup> and 2<sup>nd</sup> in lab
- Sources of errors
- 95% said shadowing of lab = beneficial
- 74% said shadowing when hired

\*Shadowing not to replace IPE in school
